Types of Financial Aid and How to Apply

TO APPLY FOR AID, COMPLETE THE ITEMS BELOW:

After January 1, 2016, complete the 2016-2017 Free Application for Federal Student Aid (FAFSA) online at www.fafsa.gov. You will need:

- Your social security number
- Driver's license number
- Use the IRS data retrieval option when completing the FAFSA to import your tax information from the IRS or, have a copy of your 2015 Federal Income Tax Return—1040, 1040A or 1040EZ. You will also need record of any untaxed income (such as child support received). If you are a dependent (single, under 24 years old, and do not have children), you will also need the above information for your parents.

The Federal Processor will forward the application to the school within 7 days.

If your file is selected for verification, you will be asked to submit a copy of your 2014 IRS tax <u>transcript</u> and/or income information to the school for review. If there are errors on your application, the Financial Aid Office will make the appropriate corrections to your FAFSA.

TYPES OF AID AVAILABLE

Federal Pell Grant

Grants are awarded by the federal government to students who show extreme financial need. For the 2015-2016 academic year, the maximum grant is \$5,775. A student's lifetime eligibility for Pell is 12 semesters.

Federal S.E.O.G. Grant

Grants are awarded by the Financial Aid Office to low-income students with exceptional financial need until the annual allocation of funds are exhausted. The minimum award is \$250 per term.

New York State Tuition Assistance Program (TAP)

This entitlement program is based on New York state taxable income for New York state residents attending college full-time in the state. Maximum annual award is \$5,000.

Loans

Federal student loans are guaranteed as long as the student is enrolled at least half-time, is not in default on a prior student loan, and has met all other eligibility criteria.

Subsidized Loan

This loan is based on federal eligibility guidelines. As of July 1, 2014, the interest rate is fixed at 4.29 percent. Interest begins to accrue after a 6 month grace period or if student drops to less than half-time status. Repayment begins six months after graduation or if the student drops to less than half-time status. Freshmen may receive up to \$3,500, sophomores up to \$4,500.

Unsubsidized Loan

The interest rate is fixed at 4.29 percent. Interest begins to accrue when the loan is disbursed. Dependent student may qualify for up to \$2,000 while independent students may qualify for up to \$6,000.

Parent Loan for Undergraduate Students (PLUS)

The 2015-16 interest rate is fixed at 6.84% for Direct PLUS loans. Repayment begins 60 days after the final disbursement or may be deferred until six months after the student graduates or drops below half-time enrollment . The yearly limit is equal to a student's cost of attendance less any other financial aid.
